Stable product.

11 - TOXICOLOGICAL INFORMATIONS.

Ingestion: No effects identified

Inhalation: Irritation of mucus membranes

Cancerogenic effects: None identified

Mutagenic effects: None identified

Chronic effects: None identified

By inhalation: Exposure to aerosols of the product and to small particulate powders showed no noxious activity (rabbit).

By ingestion: DL50 > 100g/kg

Eyes: On rabbits, no primary ocular irritation observed.

Sensitisation: Long-term; by ingestion, studies on rodents and dogs showed no noxious activity at dosages up to 10 % of total diet (study duration 28 and 90 days for rats and 28 and 180 days for dogs).

Specific effects: Non-mutagenic. No embryotoxic effects at up to 10 % of diet.

12 - ECOLOGICAL INFORMATIONS.

Partial biodegradability of the organic components.

Biologically not degradable for the fraction of mineral origin.

13 - DISPOSAL CONSIDERATIONS.

Organic product, biodegradable, except for the mineral fraction of the product.
